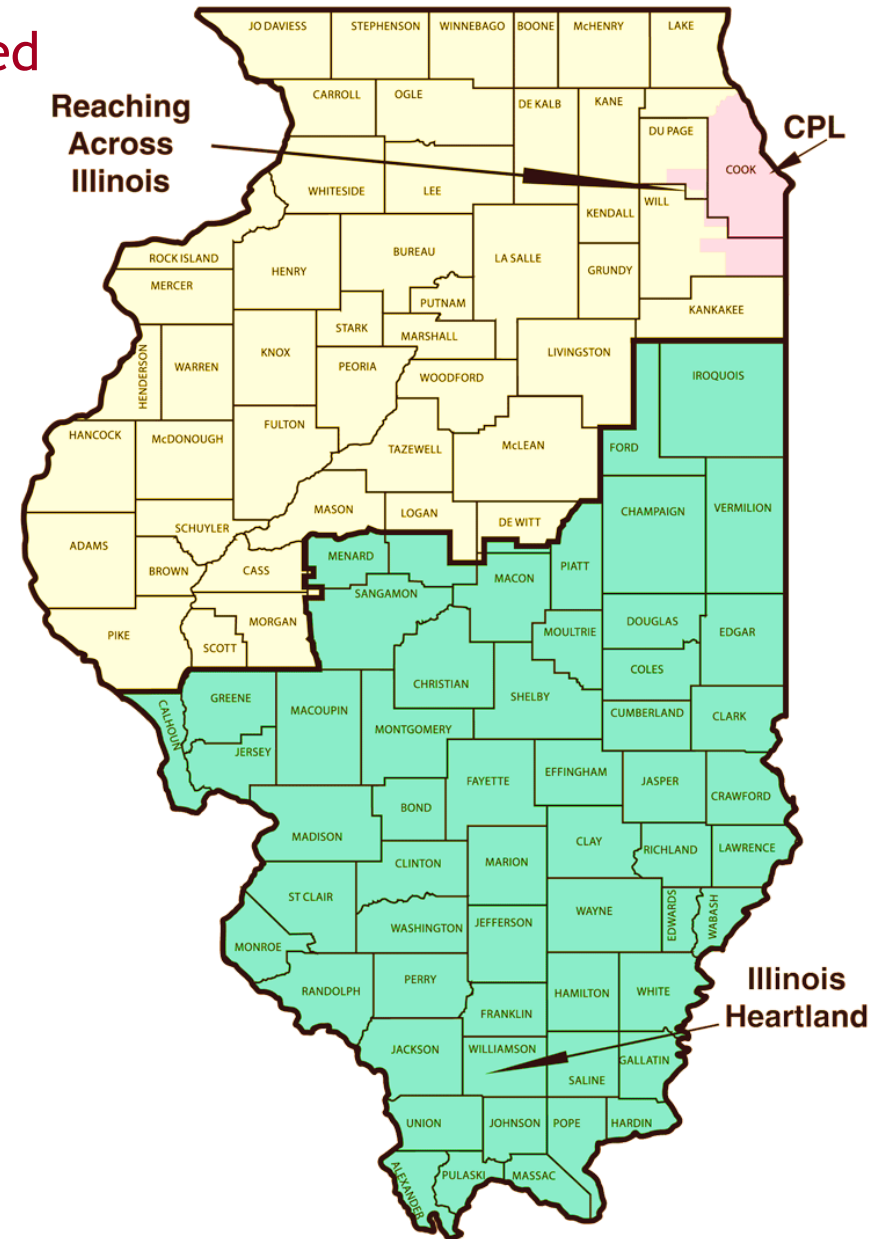

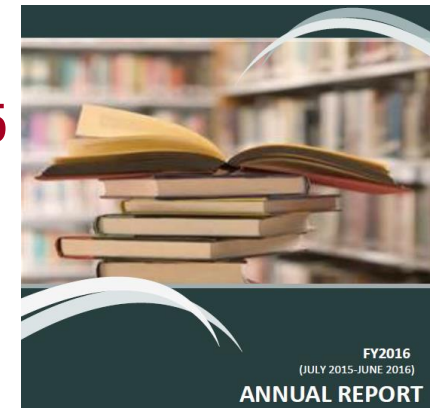

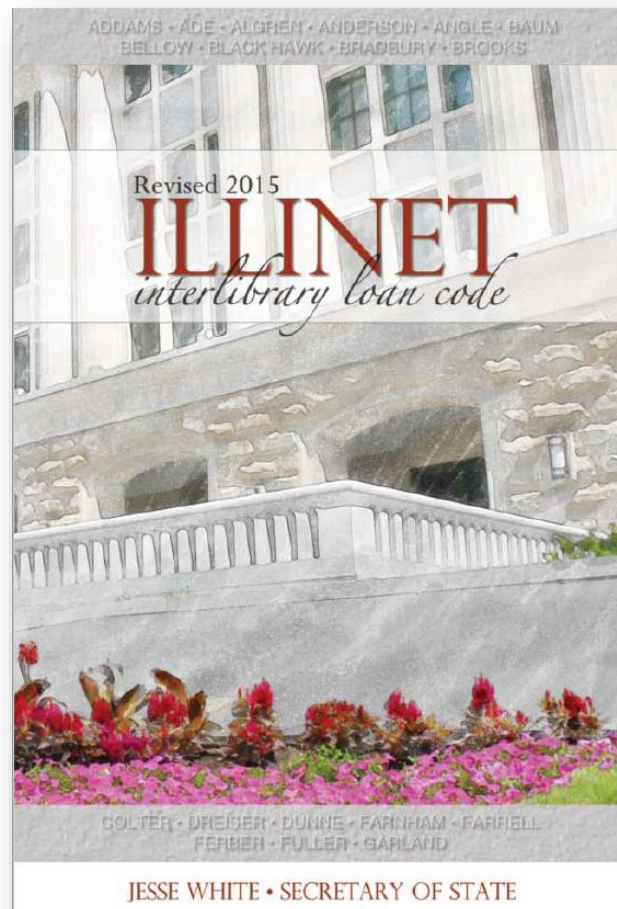
“The State Librarian shall provide for a hearing under the procedures in the Subpart to reconsider decisions made in the administration of the Act regarding....”
