RE: FY2021 SHARE Budget Amendment

On November 10, 2020, IHLS received an award letter from Secretary of State Jesse White for the purchase of e-books in the amount of \$125,000.00. Funding for this grant was awarded by the Illinois State Library, a Department of the Office of the Illinois Secretary of State, using funds provided by the U.S. Institute of Museum and Library Services, under the provisions of the Coronavirus Aid, Relief, and Economic Security (CARES) Act.

These funds will be utilized to purchase e-books to support member libraries and their communities.

Attached please find our amended SHARE Fund budget for your review and consideration to present to the Executive Committee at their January 13th meeting. The proposed amendment will need final approval by the board at their January 26th meeting.
