 RE: Vehicle Surplus List

We are presenting the list of vehicles available for sale with proposed minimum bids requiring board approval. The minimum bid values were calculated at 75% of Kelley Blue Book private sale in good condition. One exception is the vehicle with license plate U29923, which is listed in fair condition due to missing a catalytic converter. Kelley Blue Book does not provide values for cars in poor condition. The other exception is vehicle U31660, as they do not list box truck values on Kelley Blue Book.
